PROFESSIONAL FEES (AUD)

- **1. Standard Rate** Charged at rate per hour pro-rata (for time used) \$ 240
- 2. Consultation Plans Paid in advance, charged at rate per hour pro-rata (for time used):

Plan A:	Buy 6 Hours Professional Counselling Consultations @ \$198 per hr	\$ 1,188
Plan B:	Buy 10 Hours Professional Counselling Consultations @ \$180 per hr	\$ 1,800
Plan C:	Buy 15 Hours Professional Counselling Consultations @ \$150 per hr	\$ 2,250

PLEASE NOTE: Unused prepaid counselling plans expire two years from date of purchase.
